I hereby understand and agree to this release of liability, waive of legal rights and assumption of risk, and to the terms hereof as follows. (1) I acknowledge that freestyle BMX is an action sport and recreational activity involving travel in three dimensions and such activity is subject to mishap and even injury while participating in the sport. (2) I hereby RELEASE and DISCHARGE the Amigos of Dave bike day organizers, their officers, agents and owners of equipment and the land used for action The Amigos of Dave Bike Day (herein collectively referred to as "Released Parties") from any and all liability, claims, demands, or causes of action that I may hereafter have for injuries, disability, death or damages arising out of my participation in the Amigos of Dave Bike Day, included, but not limited to, losses, CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. (3) I understand and acknowledge that freestyle BMX riding has inherent dangers that no amount of care, caution, instruction, or expertise can totally eliminate. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING AT THE AMIGOS OF DAVE BIKE DAY WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. (4) I further agree that I WILL NOT SUE OR MAKE A CLAIM against the released parties for damages or other losses sustained as a result of my participation in the Amigos of Dave Bike Day. (5) I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgements, and costs, including attorney's fees, incurred in connection with any action brought as a result of my participation in the Amigos of Dave Bike Day. (6) I will take full responsibility for, and hold harmless Released Parties for any injury that I may suffer or inflict upon others or their property as a result of my engaging in the Amigos of Dave Bike Day and Freestyle BMX. (7) I have read and understand the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgement of the assumption by me of all risks arising out of my engaging in the Amigos of Dave Bike Day. (9) I further represent that I am at least 18 years of age or that as the parent or legal guardian I waive and release any and all legal rights that may accrue to me or my minor child as the result of any injury that my son or daughter (minor) my suffer while competition at the Amigos of Dave Bike Day. (10) I hereby expressly recognise that this release of liability, waiver of legal rights and assumption of risk is a contract pursuant to which I have released any and all claims against the Released Parties. (11) Right to use image: In participating in the Amigos of Dave Bike Day, I hereby grant permission to the Organizers, the right to use my physical likeness without restriction in any promotion or promotional material created by or for the Amigos of Dave Bike Day programs or events.
